2012 ENROLLMENT POLICIES

REGISTRATION POLICIES:

- ◆ Purchase Day Camp will accept applications for all **Purchase Residents, 2011 Camper Families (campers and their siblings) and 2011 - 2012 Purchase Children's Center Students** until October 15, 2011 at 5:00pm. All applications received during this time period will be guaranteed enrollment in the 2012 camp season.
- ◆ Registration for all other campers will begin on October 20, 2011 at 9:00am. Enrollment space is based on the number of groups provided per grade level. Applications will be processed in order received and enrollment cannot be guaranteed.
- ◆ All applications must be completed in full including checking the box for EACH week requested. Incomplete applications **WILL NOT** be processed until completed. You must choose a minimum of 3 weeks. Any combination of weeks is acceptable.
- ◆ Half-day and Mini Day programs are available to preschoolers and MiniK programs are available to children entering Kindergarten in the Fall of 2012.
- ◆ A Late Registration Fee of \$200 will be charged for applications received after May 1, 2012.
- ◆ Special Placement Requests **MUST** be submitted in the space indicated on the original application. Purchase Day Camp cannot guarantee the ability to honor all Special Placement requests.
- ◆ Campers must be a minimum of 3 years of age by September 1, 2012 and be toilet trained prior to camp's starting date. (Copy of Birth Certificates for 2009 birth dates required).
- ◆ Additional week extensions must begin on a Monday. Partial weeks not permitted. Requests for extensions must be submitted to the office by noon on the preceding Friday.
- ◆ Purchase Day Camp cannot guarantee space availability for additions or extensions in enrollment.
- ◆ To guarantee the availability of complimentary gifts, the gift portion of the enrollment application must be completed.
- ◆ Attendance at special programs requires enrollment during the week of the event.

PAYMENT POLICIES

- ◆ A deposit check of \$1,000 per child is to accompany each camp application. **Checks or Credit Card Authorization Forms are acceptable.**
- ◆ Parent must submit valid credit card information that authorizes Purchase Day Camp to charge their card for balances due.
- ◆ A second payment of \$1,000 per child is due on or before February 1, 2012.
- ◆ The balance of camp fees and charges is due on or before April 1, 2012.
- ◆ Payment is the responsibility of the person signing the application and bills will be sent to his/her attention.

TRANSPORTATION POLICIES:

- ◆ Bus Transportation requests are accepted in the program on a geographic basis with enrollment priority a consideration.
- ◆ Bus Transportation is not guaranteed. Requests will be reviewed and confirmed after your application is processed.
- ◆ If Bus Transportation is denied, all deposits will be refunded.
- ◆ Bus Transportation is not provided at Mid-Day.
- ◆ Actual camper time spent on bus transportation depends on bus routing and a specific time limit spent in transit cannot be guaranteed.
- ◆ State Law requires an A.A.A. approved booster seat for all children under the age of 4 on bus transportation. A.A.A. approved booster seats must be provided by the parent, guardian or bus company and must be left in the bus for the duration of the enrollment.

REDUCTION AND CANCELLATION POLICIES:

- ◆ All enrollment and transportation reductions and cancellations must be submitted to the camp office in writing and will be processed upon receipt by the camp office. All deadlines will be strictly enforced, time being of the essence with respect to every provision contained in this contract.
- ◆ The Refund Policy on all canceled applications will be as follows:
 - ◆ On or before February 1, 2012 - 100% refund for canceled applications.
 - ◆ Between February 2, 2012 and April 1, 2012 - All applications canceled result in a forfeit of the deposit and the second payment; a total of \$2000.00.
 - ◆ After April 2, 2012 - All applications canceled result in a forfeit of full camp payment.
- ◆ In the event of cancellation of this contract on or after February 2, 2012 and before April 2, 2012, the Purchase Day Camp will, as a result of its Flexible Enrollment Policy, suffer damages, the exact amount of which are impossible to ascertain at this time. It is therefore expressly understood and agreed that in the event of cancellation of this contract on or after February 2, 2012 and before April 1, 2012, the amount of \$1,000 paid upon the execution of this contract as well as the second installment of \$1,000 payable on February 1, 2012 shall be deemed liquidated damages and shall be retained by the Purchase Day Camp as liquidated damages and thereafter this contract shall be canceled and of no force and effect. If the second installment of \$1,000 has not been received by the Purchase Day Camp at the time of cancellation, the amount outstanding shall be due and payable to the Purchase Day Camp immediately.
- ◆ In the event of cancellation of this contract on or after April 2, 2012, the Purchase Day Camp will, as a result of its Flexible Enrollment Policy, suffer damages, the exact amount of which are impossible to ascertain at this time. It is therefore expressly understood and agreed that in the event of cancellation of this contract on or after April 2, 2012 the total amount of all fees and charges then due and payable shall be deemed liquidated damages and shall be retained by the Purchase Day Camp as liquidated damages and thereafter this contract shall be canceled and of no force and effect. If the total amount of fees and charges has not been received by the Purchase Day Camp at the time of cancellation, the amount outstanding shall be due and payable to the Purchase Day Camp immediately.
- ◆ All children who attend Purchase Day Camp must be toilet trained prior to camp's starting date. It is the parent's obligation to notify the Day Camp office prior to February 1, 2012 if the child is not currently toilet trained. In the event of a cancellation for this reason, all enrollment reduction policies will be strictly enforced.
- ◆ Prior to April 1, 2012, any reduction in the original enrollment will be assessed a \$100/child/week administrative fee. Transportation reductions are subject to a \$25 administrative fee/child/change.
- ◆ On or after April 2, 2012, full payment is required for cancellations or reductions in enrollment weeks from the camp or transportation programs. No refunds or adjustments on paid or unpaid balances will be permitted. Enrollments are nontransferable.
- ◆ No fee or program adjustments will be granted for camper absences.

MISCELLANEOUS POLICIES:

- ◆ Waiting list applications must be accompanied by a \$1,000 deposit, which is fully refundable, if the child cannot be placed in the program.
- ◆ Purchase Day Camp is closed on July 4th.
- ◆ Medical reimbursement accident insurance is included in the Base Fee.
- ◆ The undersigned acknowledges that he/she has read and agreed to the release accompanying this application and has included a signed copy of the release with his/her submitted camp application.
- ◆ The Camp will release children to either parent or persons authorized by same on site at any time during the day if parental arrangements for pick up have been made beforehand with the camp office. All visitors must sign in at the office.
- ◆ Photographs and group parties cannot be guaranteed in the event of a camper's absence or enrollment option or photographer error. No retakes are permitted on group or individual photos.
- ◆ **Medical forms, complete with records of up to date immunizations must be completed with doctor's and parent's signature by May 1, 2012. Due to Health Department regulations, failure to comply will affect enrollment status.**
- ◆ I understand that the Camp will make my email, phone number and mailing address available to the camp population for car pool and play date purposes unless directed otherwise in writing.
- ◆ The camp is given irrevocable permission and authorization to use the child's photograph, portrait or image in connection with the camp's brochure, web site, video or any other means of promotion or advertising.
- ◆ Purchase Day Camp reserves the right to refuse the enrollment of any child or to cancel this enrollment agreement at any time based on its sole and exclusive determination that the child's physical, mental, or emotional condition, would prevent that child from participating safely and satisfactorily in the programs offered; would prevent the child from interacting positively with other campers or TEAM Members; or would negatively impact on Purchase Day Camp's ability to offer its fundamental services. The Camp can initiate the cancellation of this agreement and the dismissal of the child if, during the camp season, the child or his/her agents exhibits unacceptable behavior which prevents our TEAM Members from safely supervising him/her or proves detrimental to himself/herself, other campers or TEAM Members as determined by the Camp Director.
- ◆ The Purchase Day Camp is required to obtain a permit to operate from the New York Department of State. The Camp is also required to be inspected twice each year by the permit issuing authority. Information concerning these inspections is filed with the Westchester County Department of Health, Bureau of Public Health Protection, 118 N. Bedford Rd., Mt. Kisco, New York 10549.

RELEASE

In consideration of participating in the activities at the Purchase Community, Inc. 1. I hereby acknowledge and accept that the activities and use of some of the equipment at the PCH may involve inherent risks and could result in injury. I know the nature of the activities that my child is participating in and believe that my child is qualified to participate in the activities. I expressly state that my child is in good health and has no limitations that would preclude my child's safe use of the equipment and facilities of the PCH. I acknowledge that if I deem the facilities and the equipment of the PCH to be unsafe I will not have my child participate in the related activity.

2. I hereby release, indemnify and discharge the PCH, its employees, volunteers, directors, affiliates, agents and successors and assigns, from any and all liabilities, suits, claims, and damages (including attorneys' fees) incurred by me or my child arising out of the use or intended use of the PCH, its equipment or its facilities, including, without limitation, all claims for property damage, personal injuries or wrongful death, other than as a result of gross negligence, or intentional misconduct of the PCH.

3. I understand that the PCH and its personnel have the right to deny access to its facilities to any individual permanently or for a specified period of time, for any breach of any of the rules and regulations of the PCH and for any conduct that is viewed as unsafe or inappropriate.

4. I expressly state that I have read this document and I understand all of its provisions and that I fully acknowledge the nature and extent of the activities conducted at the PCH and the use of the facilities.

5. I hereby voluntarily assume those risks and understand that I will be solely responsible for injury, loss, damage or death to my child while my child is using the facility and participating in the activities therein.
